Corporate or Institutional Membership



The Company applying for the corporate membership nominates a minimum of four persons for membership. Additional members may be added at any time; however, the membership must be kept at four persons at all times. The Corporate membership is based on single membership fees (\$98.00 including GST) but includes a spouse or common-law partner and up to three children under the age of 18.

Monthly membership fees are \$93.33 plus Gst \$4.67= \$98.00 (per person)

Minimum total of \$392.00 per month

All dues are billed to the Company at the end of each month.

All other charges are billed to the individual each month.

Accounts must be paid in full upon receipt of statement. Interest accrues at 2% monthly on the unpaid balance. Membership may be cancelled for nonpayment of account.

The Company's signing officer pays the total dues once a month. They are responsible for collecting from the employees for the monthly dues.
